WHEREAS the Clark Municipal Swim Pool Utility has solicited proposals for operating and maintaining the pool food concession stand for the 2012 season; and

WHEREAS two attempts were made to solicit bids by public advertisement with the openings scheduled in accordance with the Local Public Contracts Law on March 7, 2012 and April 4, 2012; and

WHEREAS no bids were received on March 7, 2012 and two bids were received in connection with this solicitation on April 4, 2012 which did not meet the minimum requirements of the Bid Specifications; and

WHEREAS on April 16, 2012 the Governing Body authorized negotiations with the vendors who submitted proposals in accordance with the Local Public Contracts Law; and

WHEREAS negotiations with the two aforementioned bidders did not result in a successful contract; and

WHEREAS the Township solicited proposals for a third time with the bid opening held on Tuesday, May 8, 2012; and

WHEREAS one bid was received from PAIR Properties LLC, 80 Williamson Avenue, Bloomfield, New Jersey 07003 in the amount of \$3,000.00; and

WHEREAS the Business Administrator has reviewed the bid specifications along with all the required documents included with the proposal and recommends award of bid to PAIR Properties LLC.

NOW, THEREFORE BE IT RESOLVED that the Governing Body of the Township of Clark, as the Municipal Pool Utility, does hereby award a contract for the Operation and Maintenance of the Pool Food Concession Stand for the 2012 pool season to PAIR Properties LLC of Bloomfield, NJ in accord with the bid documents with payment by the vendor in the sum of \$3,000.00 to the Township and compliance with all the applicable terms and conditions as set forth in the aforesaid specifications.
