**WHEREAS** due to the late adoption of the State of New Jersey’s Budget, the Union County Board of Taxation is unable to certify tax rates throughout Union County and the Clark Township Tax Collector will be unable to mail the Township’s 2024 tax bills on a timely basis; and

**WHEREAS** the Clark Township Tax Collector in consultation with the Clark Township Chief Financial Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.33 and they have both signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted estimated tax levies.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Clark, in the County of Union and State of New Jersey on this 17<sup>th</sup> day of June 2024, as follows:

1. The Clark Township Tax Collector is hereby authorized to prepare, and issue estimated tax bills for the Township for the third installment of 2024 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by P.L. 1994, c.72 (N.J.S.A. 54:4-66.2 and 54:4-66.3)
